

# EGPRN FEE SYSTEM from 1 JUNE 2014 until 31 MAY 2017

EGPRN has:

- Individual memberships (full, reduced, reduced for direct Wonca members, reduced for special categories)
- Institutional memberships (full, reduced)
- Conference fees (full, reduced for members, reduced for special categories)

### Membership EGPRN

There are two types of memberships: individual and institutional. Membership fees preferably are paid by bank transfer/credit card, using the e-payment facility of the EGPRN website(s). Cash and cheque payments will cost 10% extra, to cover the costs of bank charges.

EGPRN prefers memberships of three years. In the new system the 3 year period is "rolling", which means you can become a member for 3 years at any time. A one-year membership is possible but we will invite these members to extend their membership to a full three year membership before the one year period is over. In that case we will not charge extra costs. There are two conferences per year and therefore six conferences in your 3-year membership period, where you are eligible for the 'member' conference fee rate.

Where institutional membership has been taken out, two people from the institution can avail of the 'member' conference fee rate for the period. Hence for one year institutional membership, this is for two conferences and for 3-year institutional membership, this is for six conferences.

The next three year period is from 1st June 2014- 31st May 2017. This period includes 6 EGPRN Conferences (Autumn 2014 – Spring 2017).

## RULES

### Conference Fees

An EGPRN meeting consists of two Conference days (Friday and Saturday, with Practice Visits on Friday and a Social Night on Saturday). On Thursday there are Pre-conference Workshops and an Opening Reception. Furthermore, the Executive Board, the Council and various standing Committees meet on Thursday. EGPRN-Members as well as conference participants who are not a member of EGPRN, will pay a Conference Fee (plus optional extra fees) for each meeting. Fees preferably are paid by bank transfer/credit card, using the e-payment facility of the EGPRN website(s). Cash and cheque payments will cost 50 Euros, to cover the costs of bank charges.

1. INSTITUTIONAL MEMBER: two non-member participants can subscribe per congress as "member" (in 3 years, 6 non-members from the institution can come as "member")
  2. EARLY BIRD FEE: is only for members, and runs until one week after receiving acceptance letter
  3. LATE REGISTRATION FEE: payment after 2 weeks before start of the meeting
  4. REDUCED FEES: for <30y (on day of subscription) and low income countries (see table below )
  5. LOCAL ORGANIZER RECEIVES:
    - social night payments
    - payments for preconference workshops
    - a guarantee of maximum 75 Euro per paid participant: BUT under CONDITIONS: approved financial plan and if no covering by sponsors / for max 150 participants / based on the financial plan of future hosts in dialogue with EB / if costs are covered by sponsor money, then less EGPRN-money. To be clear: If all costs are covered, then EGPRN does not pay these €75 (no profit for local organisers). What covers this €75? Coffee breaks, lunches, rent of rooms. Not covered are: gala dinner; secretarial costs; wages of conference organisers.
5. PROJECT FUNDING:
- max budget approved to 8000 Euro per year (one = 8000, two = 2x4000)
  - time line necessary – if aims not reached, stops funding
  - real costs – no estimates and following the rules from research committee
